Website Progress

• All website responsibilities have been shifted from Eric Brown to John Serrao.

2023 Events

- Ryan Mikulenka has confirmed the Oak Hill Fire Department for the parade.
- Jen Martin has arranged with ATX Fire Burgers to bring food truck service for the event.
 Hamburgers, sliders, hot dogs, wraps and popsicles will be available for purchase. There is a \$1000 minimum for the food truck and the HOA will cover any shortage. We have met this minimum in previous year and do not expect it to be an issue this year.
- The event will be publicized in a special event email to members, included in the July member email, Facebook and Granada Hills HOA website.
 - Sarah Matteson has expressed interest in organizing a dive-in movies night at the Pool in August.
- Scott Budd has a projector and scree that is available to the HOA. Ryan Mikulenka will check with Carson Coots regarding a sound system.

- Roy Ribelin had recently built and installed a 'granadahillshoa.org' sign that hangs from the bottom of the Granada Hills sign at El Rey and Espanola.
- Scott Budd would like to have a Fall Park Day in October.

Pool

- City of Austin pool permit for the kiddie pool was given to Scott Budd for posting.
- A decision to not transition from AT&T to Spectrum was made due to the cost for service by Cothron's to reset the IP address on the gate controller. Eric Brown worked with AT&T to ensure that the account was transferred to Mary Woodruff.

Tennis Court

Report provided by Gina Budd

- Rental of Court for Non-Resident Lesson
 - A tennis instructor approached me about renting Granada court for lessons for <u>non-residents</u>. He is the same instructor that coaches Waldorf Kids.
 - Recommendation: I don't think we should do this...opens up a can of worms. However, lessons are fine for HOA members.
 - Recommendation: Speaking of Waldorf, since they are requesting 2 days of reservations at prime "after school" time, if we continue to allow them to rent next year, I recommend we charge them more. Currently we only charge them \$60 per 3-hour session—this year was \$960 total. I suggest a different pricing model such as \$120 or \$150 per 3-hour session.
- Non-Resident Tennis Members
 - For non-residents, rather than them join as "member of the HOA", I recommend they pay a specific annual tennis membership...which could be HOA cost + tennis membership. Even if we charged \$400 \$500 annually for non-resident tennis membership, it is a lot less than Grey Rock.

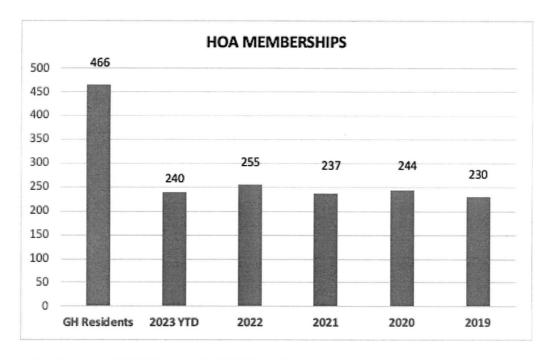

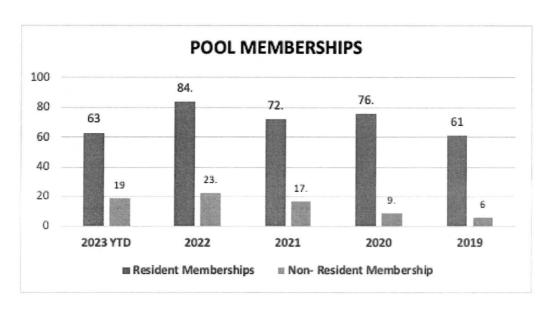
